

MR D.I.Y. x Visa: Spend & Win FIFA World Cup 2026™ Final Match Trip

TERMS AND CONDITIONS

1. INTRODUCTION

- 1.1. **“MR.DIY x VISA: Spend & Win FIFA World Cup 2026™ Final Trip” (“Campaign”)** is organized by MR. D.I.Y. Trading Sdn. Bhd. (Company No: 200901036305 (879428-V)) (“MR.DIY”) together with its official partners for the Campaign (“Partners”) for Eligible Participant with Qualifying Entries to stand a chance to win Prizes. By participating in this Campaign, you hereby expressly agree to be bound by these Terms and Conditions and any decisions made by MR.DIY in respect of this Campaign shall be final and binding.
- 1.2. The Campaign commences from 12th March 2026 until 19th April 2026 at 11:59 PM, both dates inclusive (“Campaign Period”).
- 1.3. MR.DIY reserves the right to amend, shorten or extend the Campaign Period at its sole discretion without prior notice. All entries received outside the Campaign Period shall be automatically disqualified.

2. ELIGIBILITY

- 2.1. The Campaign is open to all citizens and permanent residents of Malaysia, aged 18 years (at the start of the Campaign Period) and above with a valid VISA-branded payment card.
- 2.2. Employees of MR.DIY and Partner (including its affiliated and/ or related companies, distributors, dealers, advertising and promotion agencies or related thereto) and their immediate family members (children, parents, siblings, including spouse) are **NOT ELIGIBLE** to participate in this Campaign.

1. Card type / name: VISA
2. Date of transaction must be within the duration of the campaign, 1 March - 19 April 2026
3. Amount Spent: RM 50 or above in a single receipt
4. Transaction / Invoice Number

Note: Each receipt submitted will be given ONE (1) random serial number per entry (one entry per purchase receipt regardless of the amount spent). (Note: serial number is for the MR.DIY reference/view only and will not be disclosed to the Participant).

4. **CAMPAIGN MECHANICS AND CONDITIONS**

- 4.1. Eligible Participant must spend at any MRDIY stores, using Visa-branded payment card, a minimum of RM 50 in a single receipt (“**Qualifying Spend**”) to be eligible to enter the draw to win the Prize(s) as listed in **Clause 5** .
- 4.2. Upon successful registration, the Eligible Participant will need to meet the Qualifying Spend to earn “Qualifying Entries” and stand a chance to win the Prize(s).

5.2. Selection of Winners

- 5.2.1 Based on the Qualifying Entries earned, Eligible Participants stand a chance to win the Prizes, after being shortlisted by MR.DIY's randomizer program.

- 5.2.2 Selection will be carried out after the end of the Campaign Period, as announced by MR.DIY.
