

## **Terms and Conditions for Event Passport & Tote Bag Redemption**

The following terms and conditions (the “**Terms and Conditions**”) shall apply to the **Bersama Satu Bazaar Event Passport and Tote Bag Redemption** (the “**Activation**”) hosted by **MR.DIY** (the “**Organiser**”).

### **Eligibility**

1. Each Event Passport is valid for one (1) participant only and cannot be transferred, exchanged, or duplicated.
2. Employees of MR.DIY, their immediate families, affiliates, subsidiaries, related agencies and suppliers, and/or persons living in the same household are ineligible to participate in the Activation.

### **Activation Period**

1. The Activation will run from **29 August 2025 to 1 September 2025** (the “**Event Passport & Tote Bag Redemption Period**”).

### **Participation in the Activation**

1. To participate, each guest must register at the entrance registration counter to receive one (1) Event Passport.
2. To redeem a tote bag, participants must collect **all four (4) stamps** on the Event Passport by completing the following activities:
  - **Stamp 1:** Register at the entrance counter.
  - **Stamp 2:** Play any game or join any activity at *Jalan Fun*.
  - **Stamp 3:** Spend at *Jalan DIY* and present the receipt at the Redemption Counter.
  - **Stamp 4:** Snap, post, and tag on social media with **#BersamaSatuBazaar**, then show proof at the Redemption Counter.
3. Redemption is strictly on a **first-come, first-served basis**, limited to 1,000 bags per days, while stocks last.
4. Each participant is entitled to **one (1) tote bag only** upon presenting a fully stamped Event Passport.
5. Incomplete, damaged, or altered Event Passports will not be accepted.

## **Tote Bag Redemption**

1. Tote bag personalization/customization is only available after participants have successfully completed the stamp collection and redemption.
2. A list of completed tote bags will be displayed on the TV screen at the event area.
3. Tote bag redemption can only be made during the 4-day event at the Redemption Counter.
4. Tote bags are **not transferable** and **not exchangeable for cash or other items**.
5. The Organiser reserves the right to substitute the tote bag with another item of similar value if necessary.

## **General**

1. By participating in the Activation, participants are deemed to have accepted and agreed to be bound by these Terms and Conditions and any other instructions, terms, or conditions issued by the Organiser from time to time.
2. The Organiser shall not be liable for any loss, damage, injury, or expense arising from participation in the Activation or from redemption of any rewards.
3. The Organiser reserves the right to withdraw, cancel, amend, or vary the Activation or these Terms and Conditions at any time without prior notice. The Organiser's decision on all matters relating to the Activation shall be final and binding, and no correspondence will be entertained.
4. Participants shall indemnify and hold the Organiser harmless against any claims, losses, damages, costs, or expenses (including legal fees) arising from their breach of these Terms and Conditions.
5. In the event of any inconsistency between these Terms and Conditions and any promotional or marketing materials, these Terms and Conditions shall prevail.
6. In the event of inconsistency between the English version and any translated versions of these Terms and Conditions, the English version shall prevail.
7. These Terms and Conditions shall be governed by and construed in accordance with the laws of Malaysia, and the Courts of Malaysia shall have exclusive jurisdiction over any disputes.
