

Blue Cap Run 2025 Lucky Draw

Terms and Conditions for Lucky Draw

The following terms and conditions (the “Terms and Conditions”) shall apply to the Blue Cap Run 2025 Lucky Draw (the “Promotion”) hosted by Yayasan MR.DIY (the “Organiser”).

Eligibility

1. Participants must have a valid Running Bib Number, complete with a valid name, mobile number, and shall be physically present during the lucky draw session.

Lucky Draw

1. The lucky draw sessions will be held during the Blue Cap Run 2025 on ground event day on 2 November 2025 (the “Promotion Period”).

Participation in the Promotion

1. Participants must be a registered participant of Blue Cap Run 2025 and present during the sessions to qualify for the lucky draw.
2. Participants are entitled only one entry to the Promotion throughout the Promotion Period if the qualification requirement is met.

Conduct of Lucky Draw and Prizes

1. There will be 48* winners to be picked during the Lucky Draw split in 2 sessions (refer table below). (**subject to change*)

2. Each winner is only entitled to win one prize. In the event a participant is picked for more than one time, the Organiser shall be entitled to disregard the second and subsequent picks and re-pick a winner.

Prizes

1. The Organizer, its agents, sponsors, and representatives shall not be held responsible for any Participant who fails to claim the Prize according to the Prize Claim/Delivery Date requirements under any circumstances. The Organizer reserves the right to determine the management of any unclaimed Prizes.

2. Prizes are strictly non-transferable, non-assignable, non-exchangeable, and non-redeemable by the Participant in any form or manner other than that determined by the Organizer.
3. Any additional costs not specifically stated in the Participation Terms Schedule related to the Prize shall be borne by the Winner.
4. All Prizes must be claimed in accordance with the terms and conditions of the Organizer, its agents, sponsors, or any third party providing the Prize.
 - a. Event Tickets:

The Organizer shall not be held responsible for any cancellation or rescheduling that may prevent the redemption of the Prize. Tickets may only be used on the date stated on the ticket.
 - b. Travel/Flights Prizes:

If travel is offered as a Prize, flights are subject to availability at the time of booking. The Prize must be claimed according to the dates and destinations determined by the Organizer, its agents, or sponsors. Expenses for additional costs, meals, taxes, valid passports, visas, transportation to and from the departure point, additional travel, insurance, and all incidental expenses not specifically stated in the Participation Terms Schedule shall be the responsibility of the Winner.
5. Prizes are awarded on an “as is” basis. Prizes must be used/claimed entirely at the Participant’s own risk, and the Organizer makes no warranty nor assumes any liability in connection with the Prizes to the extent permitted by law.
6. Prizes must be claimed in person unless the Organizer specifies an alternative method of claim.
7. In cases where a Participant under the age of eighteen (18) years is declared a Prize winner, the Participant must be accompanied by a parent or legal guardian throughout the Prize presentation ceremony.

Prize Collection

1. The winner's bib number will be announced during the lucky draw sessions.
2. Winners need to be present to receive the present on stage or give necessary information on the day of the event for prize redemption.
3. The prizes are not transferable, exchangeable for cash or any other items. The Organizer reserves the right to award a different prize equivalent in value of the prize.

Publicity

1. The Organizer may use a Participant’s entry, including but not limited to photographs, drawings, text, and any other content or information submitted for the purpose of the Contest (collectively referred to as the “Materials”) as well as the Participant’s name and/or likeness for advertising, publicity, and promotional purposes related to any of the Organizer’s products, for an unlimited period of time worldwide, without compensation, and in any media. The Participant shall do all things necessary for this purpose upon the Organizer’s request.

Indemnity

1. Each Participant agrees to defend, indemnify, and hold harmless the Organizer and its holding company, subsidiaries, or related companies as defined under the Companies Act, together with their directors, officers, employees, agents, sponsors, and/or representatives, from and against any and all losses, rights, claims, actions, and damages (including special, indirect, and consequential damages) arising from or incurred as a result of the Participant's participation in the Contest, acceptance of any Prize, and/or the use of the Participant's entry and/or likeness in connection with this Contest, or any breach of these Terms and Conditions.

Limitation of Liability

1. Participation in this Promotion is at the Participant's own risk.
2. The Organizer, the Yayasan MR.DIY, their directors, officers, employees, agents, sponsors, and/or representatives shall not be held liable to any Participant for any loss or damage whatsoever suffered or incurred, including but not limited to indirect or consequential loss, or for any personal injury suffered or sustained by the Participant arising out of or in connection with the Participant's participation in this Contest, as well as the redemption and/or use of any Prize won.

General

1. By participating in the Promotion, the participant is deemed to have accepted and agreed to be bound by these Terms and Conditions and any other instructions, terms and conditions that the Organiser may issue from time to time.
2. The Organiser reserves the right to withdraw or cancel the Promotion and to amend or change these Terms and Conditions at any time for whatever reason and without giving prior notice to the participants. The decision of the Organiser on all matters relating to or in connection with the Promotion is final, and no correspondence will be entertained.
3. In the event of any inconsistencies or discrepancies between the Terms and Conditions and the contents of any brochure, marketing and/or promotional materials relating to the Promotion, these Terms and Conditions shall prevail.
4. In the event of inconsistency or discrepancy between the English version and the other versions of the Terms and Conditions, the English version shall prevail.
5. The Promotion Terms and Conditions shall be governed by and interpreted in accordance with Malaysian law. The Courts of Malaysia shall have exclusive jurisdiction over any disputes arising from these Terms and Conditions, including the validity and enforceability thereof.
