

Terms and Conditions for Lucky Draw

The following terms and conditions (the “Terms and Conditions”) shall apply to the Bersama Satu Bazaar Lucky Draw (the “Promotion”) hosted by Mr. DIY (the “Organiser”).

Eligibility

1. Participants must fill up the lucky draw ticket with a valid name and mobile number.
2. Employees of Mr. DIY, their immediate families, affiliates, subsidiaries, related agencies and suppliers and/or persons living in the same household are ineligible to join the lucky draw.

The Organiser reserves the right to withdraw or cancel the Promotion and to amend or change these Terms and Conditions at any time for whatever reason and without giving prior notice to the patrons. The decision of the Organiser on all matters relating to or in connection with the Promotion is final, and no correspondence will be entertained.

4. A participant shall fully indemnify and hold the Organiser harmless from and against any loss, damage, cost, liability or expense (including legal fees), whether direct or indirect, which the Organiser incurs in respect of, in connection with and/or arising from the patron's breach of these Terms and Conditions.

5. In the event of any inconsistencies or discrepancies between the Terms and Conditions and the contents of any brochure, marketing and/or promotional materials relating to the Promotion, these Terms and Conditions shall prevail.

6. In the event of inconsistency or discrepancy between the English version and the other versions of the Terms and Conditions, the English version shall prevail.

7. The Promotion Terms and Conditions shall be governed by and interpreted in accordance with Malaysian law. The Courts of Malaysia shall have exclusive jurisdiction over any disputes arising from these Terms and Conditions, including the validity and enforceability thereof.
